## Kings Landing Military Muster Postponed Until September!

The date for the Military Muster at Kings Landing has been changed from its original date in June to the weekend of September 17-19, 2021. This news was received by Lindsay Titus in an email from Tom Richards of Kings Landing on the morning of May 4. Also on that day, Company H members, Co. I, 20<sup>th</sup> Maine, Delancey's Brigade and interested individuals were notified of the change.

This change came about as a result of worrying Covid-19 conditions, government decisions; concerns about reenactors' abilities to travel, and the overall logistical hurdles produced by the pandemic. In an email to Lindsay Titus on April 30, Kings Landing CEO, Mary Baruth, said, "We don't want to disappoint our guests, or have our first return of the military to Kings Landing to be less than we know it can be."

With that, members of Company H, and friends of the company were surveyed about the possibility of moving the event to September. Co. H members were also asked to closely monitor their emails in the coming days, as plans for the Military Muster at Kings Landing were evolving. By May 4, survey results had been received from Co. H, 5<sup>th</sup> New Hampshire; Co. I, 20<sup>th</sup> Maine; and Delancey's Brigade, and these revealed that members of all three organizations showed a strong interest in holding the Military Muster in September, instead of June.

The survey results were sent to Mary Baruth on May 3, and on May 4, we received a reply from Tom Richards of Kings Landing: "From your research and our discussion here, it appears that the weekend of the 17th-19th of September is the best for all concerned, and takes into account the students' return to schools. Therefore we will switch the Military Muster event (18-20 June) with "Beyond the Secular World" (17-19 September) and offer the Military Muster Education Day to the students on the 17<sup>th</sup> [of September]."

Weather at that time of the year is unpredictable. We could have beautiful fall days, or it could be cold, wet and miserable. Long-serving members have experienced both. Perhaps by then the Slipp House will again be open and available to us. Please keep a close watch on your email in-box for news on this, and other events.

### Covid-19 Cancels Our Role at Air Show Atlantic

A check of the Air Show Atlantic website in mid-April revealed that, although the air show is still happening (at least of this date), there will be no static aircraft display, and no on-ground attractions or performers. That would include Co. H, 5<sup>th</sup> New Hampshire. The precise wording by organizers reads: "In order to mitigate the COVID-19 risk associated with crowds congregating on the Air Show grounds, there will not be any public ground performers or attractions at this year's show." The air show is scheduled for August 28-29 in Debert, Nova Scotia, a short distance from Truro. With the will of the Co. H membership, we will apply to participate again in 2022.

# Joe Gee: A Members-Only Facebook Page

In an email received March 5, Joe Gee offered the suggestion of creating a "members-only" page as part of our Company H Facebook page. This is an excellent idea, and in a return email, Captain Titus thanked Joe and informed him that this would be done. Since then, the Company H membership was notified of the idea, also by email.

As fate would have it, at about the same time, Facebook on Lindsay's iPad "froze" and had to be deleted. Upon trying to re-load Facebook, a message appeared, saying that Facebook no longer supports this iPad – it is just too old! Captain Titus has tried to create the members-only page from both his cell phone and his computer, but so far, to no avail. Members are asked to be patient, as he tries to "figure out" the technical steps required to set it up. In the meantime, thank you, Joe, for your idea. We will endeavour!

## Borders Are Closed! All Drills Are Cancelled or Postponed!

A news release from the website of CTV Atlantic on April 28, and revised April 29, states: "The Atlantic travel bubble has officially been delayed again – this time due to recent counts of Covid-19 and variants of concern. All four premiers met to consider the reopening, which had already been delayed from April 19 until May 3. But, for now, it's off the table until the threat of further outbreaks has been reduced. In a joint statement, the premiers said they remain optimistic that travel within Atlantic Canada will resume by summer, when most Atlantic Canadians have been vaccinated against Covid-19."

The recent or present Covid-19 restrictions established throughout Atlantic Canada have required us to cancel our planned company drill, originally scheduled for May 15 in Sussex, NB.

Emails sent to the Co. H membership in April offered the possibility of NCO's holding provincial drills as an alternative to a drill of company strength. However, Nova Scotia now finds itself under a province-wide lockdown, making a local drill there either difficult or impossible. Travel into New Brunswick from neighbouring provinces is also currently greatly restricted, as illustrated by the press release, above.

So, for two reasons: First, and foremost, because of concerns for our health; and (2) to maintain a positive relationship with the public, Captain Titus is cancelling all drills, both company and local, until further notice.

This decision is not made lightly, and indeed will be a great disappointment to most members, but safety must come first. The very nature of Civil War formations and drill requires close contact (elbow touching elbow) when in the line, and 13-inch intervals while marching, and that close proximity, sadly, is just what we must all avoid.

Please monitor your email inbox for updates, and respond as needed. As you are aware, the Covid-19 situation and government responses to it change daily, and when we can hold a drill, whether it be local or company strength, we will. But until then, get your kit together, watch Civil War "how-to" videos on YouTube, and stay well.

## Coming Soon! Membership Dues

Membership dues for 2021-22 are due no later than June 22, 2021, and that's coming right up! Membership dues pay for liability insurance through the National Firearms Association (NFA). The holding of liability insurance is required by our by-laws for each firearm-carrying member, and is often required by event organizers. Dues also contribute to the company's savings account, with money being used for purchases to benefit the company. The purchase of Dave Adams' tent for use by the company is an example of how company funds may be spent. In the future, purchases may include black powder, percussion caps, a "loaner" uniform and leather, perhaps a company musket, children's wooden muskets, national and/or regimental colours, or a variety of other needs.

The NFA membership and insurance term for us ends each June 30, and begins again on July 1. Thus, dues payments fall each year right in the middle of our usual reenacting season. In order to allow time for the gathering of membership information, to do the required banking, and to mail our list of names and payment to the NFA in Edmonton, dues payments for the 2021-22 reenacting season must be in to Lindsay Titus no later than June 22.

Dues remain at \$25.00 per firearms-carrying member, or \$25.00 per family, when family members do not carry a firearm. Dues are payable by e-transfer or cheque. Cheques should be made out to Lindsay Titus, as, in order not to pay monthly banking fees (which typically amount to \$40.00 to \$50.00 per year), Captain Titus was required to set up a personal account, not a group account. Members wishing to maintain their membership, but for whom the deadline is a difficulty during this pandemic year, are asked to email Lindsay Titus (fifthnhvcoh@rogers.com) to make payment arrangements.

Keeping this part of Canadian history alive in our region is important. It is our plan to help this organization to continue to grow. It is sincerely hoped that all current members will "re-enlist" for 2021-22, as we also seek new members, even in the midst of these trying times.

## Canadians in the Ranks of the Fifth New Hampshire

Stephen L. Hicks was born in Canada and enlisted as a substitute in Co. D on August 11, 1863, mustering-in as a private on the same day. Hicks was 19 at the time of his enlistment, which was credited to Epping. He was transferred to Co. C on November 20, 1864, and appointed corporal on January 10, 1865. Hicks was captured at Farmville, Virginia on April 7, 1865, but was paroled nine days later, on April 16. He was discharged on June 14, 1865 at Annapolis, Maryland, and died on January 27, 1888.

## Titusville Property Made Available for Drill

Sarah (Titus) Morrison is the daughter of Lindsay Titus, and she has, on several occasions, offered her family's property for our use as a drill site. The land is property long-owned by her husband's family, the Morrison's of Titusville, located near Hampton, New Brunswick.

Their home is on the property, and the house immediately next door is the home of Shawn's (Sarah's husband) parents. Behind these two houses is a vast yard and rolling hills. A dirt road has been cut for marching up a large and scenic hill. There is a barn and rail fences on the site and the hillside is a mix of fields and trees.

Titusville (how appropriate!) is just east of Saint John and about 30 minutes west of Sussex.

We now have offers of four properties for use for drill. Besides the Morrison property, Dave Adams' sister-in-law has property near Amherst, NS, that she has offered for our use as a drill site. Dave Adams and Lindsay Titus investigated the property in November 2020 (see "Battle Lines No. 27; December 5, 2020) and found it quite suitable. Aaron Bouma has offered his property near Woodstock, NB, for use as a drill site at least twice; the latest in December 2020 (see "Battle Lines" No. 28; January 5, 2021), and Barry Hippenstall offered his property, located near Cavendish Beach, PEI in January 2021 (see "Battle Lines" No. 29; February 5, 2021). - "Ghosts of Girlfriends Past" One night awhile ago my wife and I found ourselves watching the 2009 movie, "Ghosts of Girlfriends Past" on Netflix, starring Matthew McConaughey. They would be happy to build other boxes, although you would most likely have to supply your own period-correct cut nails, unless you wanted modern ones.
- **Kings Landing Updates** April saw numerous emails going back-and-forth among Kings Landing, Co. H, Co. I, Delancey's Brigade and individuals regarding the Military Muster at Kings Landing.
- Lonny Ryall Lonny Ryall of Saint John, a former member of the 20<sup>th</sup> Maine and the Columbia Rifles, sent word on April 13 that he would be unable to fall-in with us at Kings Landing in June due to his work schedule. Now there is hope, at least, that he will be able to join us on the new date in September.
